E-PROJECT MANAGEMENT / TECHNICAL SUPERVISION - SCOPE OF SERVICES

E.1 Pre-construction Phase

- **a)** Prepare the Information Memorandum clarifying the scope of the Project for the Architectural Request for Proposal (RFP) at the inception phase in coordination with the Employer.
- **b**) Preparation and launching of the Design Tender
- c) Assist the Employer in the appointment of the selected International Architect and all other technical consultants and the Marketing & Financial consultants (if required) from concept stage to operations by preparing all contract documents to be signed with the different participants.
- **d**) Monitoring all design phases and related deliverables for the following phases: Conceptual Design, Preliminary Design, Permit File, and Design Development.
- e) Insure that all pre-set timetables and deadlines are met and phase-approvals granted
- f) Managing all correspondences between the Employer and other stakeholders.
- g) Review preliminary design criteria, conceptual planning, and updated design detail
- h) Prepare a detailed feasibility study encompassing the financial model for the development.
- i) Ensure Cost Management Services including the Budget estimate, the Procurement strategy and implement Value Engineering by proposing cost savings approach and increasing efficient result that could impact and optimize the construction cost. Value-Engineering that shall be applied at key milestones stages, that is, and not limited to, provide recommendations on relative feasibility of using other construction material and method of construction to reduce cost by finding alternative designs and to improve the preliminary budget.
- j) The Project Manager will guide the design phase in a way to insure Fast Track Construction Methods in order to overlap design and construction activities and hence reduce the overall construction duration. excavation and foundation works can be started at an early stage of the design process. In fact, as soon as the final levels and foundation design are established the excavation and foundation packages can be let.
- **k**) The Project Manager shall propose a packaging strategy that optimizes the number of construction packages to produce manageable and cost effective plan without jeopardizing quality.
- l) Coordinate between the Employer and other project functions and parties such as Finance, Legal, Quantity Surveying, Interior Designer, etc...

m) Assisting the Employer in the follow up of all administrative measures for the acquisition of all needed permits until the issuance of the occupancy permit and the title deeds

E.2 Tender and Award Phase

- a) Finalize preliminary contractor's bid list
- b) Pre-qualify selected contractors and stimulate their participation in the competitive bid
- c) Prepare bid packages by tendering the whole lot to one Main Contractor or to divide the Project in several packages to be able to monitor at best the Quality, Cost and Time in a fast track construction system.
- d) Issue "Request For Tender" for invited-bidders as Main Contractors or Contractors packages
- e) Prepare a detailed fair-cost estimate for each bid package;
- **f**) Review and assessment of Tender Prices submitted by Contractors/Subcontractors and issue recommendations for adopting the most adequate Main Contractor an Subcontractors
- g) Recommend contract awards to the Employer in line with the Budget and the Master schedule.
- **h)** Issue "Notices to Commence" after Contract signature.

E.3 Construction Phase

E.3.1 - GENERAL

- Ensure that various related Consultants are enforcing all contractual requirements, particularly those that pertain to quality.
- Study all proposals made by the Consultants or by Contractor(s) in connection with possible changes
 to the external envelop and common area and to any related construction document and advise the
 Employer of their assessment.
- Ensure that a systematic process is implemented for documenting all construction-related activities, meetings, proposals, records, drawings, correspondences, visuals, and the like.
- Monitoring of Monthly reports prepared by the Contractor which include progress photographs, Contractor performance, schedule report, cost/financial report, bonds, problem areas and recommendations for action. Cause Contractor to keep accurate written reports on labor, weather, progress, materials/equipment delivery and installation, accidents and other pertinent matters.
- Monitor dispatching and feedback of Contractors'/Subcontractors' shop drawings and material
 procurement schedules and submit logs for completeness, accuracy and compliance. Insure timely
 technical review and approval of all by the related Consultant.

E.3.2 - SITE MANAGEMENT & COORDINATION

- Review and approve the Contractor's safety and quality assurance programs in conjunction with specifications set by the Engineer.
- Arrange for an initial site meeting (kick off meeting) with all parties to discuss procedures, means of communication, submittals, instructions, and forms to be adopted, etc.
- Arrange for and attend regular site meetings to monitor performance and progress and delineate any complications, prepare minutes of meetings for dispatching and actions.
- Monitor compliance with the contracts by the Contractor and his related subcontractors for various trades and ensure that the obligations of each are being honored in accordance with the contract requirements and recommend courses of action where deemed necessary.
- Administer all submittals from the Contractor(s)/Subcontractors, such as: shop drawings, products data, samples and other submittals and follow up on the timely review performed by the Related Consultant.
- Act as a center point of all communications between all parties involved in the construction process.
- Monitor the Contractor(s) practices pertaining to the delivery, storage, handling and protection of materials, systems and equipment.
- Review & approve the detailed Baseline Schedule of Works submitted by the Contractor
- Monitor the implementation of the Schedule of works, review schedule monthly updates submitted by the Contractor, identify delays and recommend corrective measures.
- Implement Contractor's contractual requirements and obligations and respond to all related correspondences
- Review/reject/validate requests made by the Contractor(s) in connection with possible extensions of the construction program's duration.
- Prepare a summary of the status of the works listing incomplete or unsatisfactory items, and a schedule for their completion and provide proposals to recover any possible delays.

E.3.3 - COST CONTROL AND FINANCIAL MANAGEMENT

- Submit an estimated cash flow based on the approved work program.
- Review and approve payment certificates issued by the Contactor or nominated Subcontractors.
- Run value Engineering approaches; recommend alternative solutions whenever design-related problems are reported to be affecting construction cost or program.
- Control and report on the expenditure of the provisional sums, if any.

- Attend periodic meetings with the Employer to report on progress, budget, and cash flow requirements and other substantial addition/omission or change to the contract.
- Evaluate/appr./reject any possible variation orders submitted by the Contractor/ Subcontractors.
- Review and evaluate all claims submitted by Contractor/ Subcontractors and prepare viable resolution strategies for their settlement, in a way that best serves the interests of the Employer.
- Monitor the Project Total Cost

E.3.4 - HANDING-OVER

- Closing out all contracts with all parties involved. Settle all pending claims and variation orders.
- Insure submittal to the Employer required warranties, guarantees, releases, bonds and waivers, keys, manuals, brochures, as-built drawings and maintenance stocks.
- Receive and file all as-built drawings after fetching approval from the Design Consultants
